By placing a bid, whether present in the saleroom or by any other means, the buyer (bidder, purchaser) agrees to be bound by the following conditions of sale:

- 1) All property is sold in "as is" condition and all sales are final. Neither Millea Bros. nor their consignor(s) makes any representations or warranties, express or implied, with respect to the property or the correctness of the catalogue or other description of the authenticity of authorship, physical condition, size, age, quality, rarity, importance, provenance, exhibitions, literature or historical relevance of the property or otherwise.
- 2) The highest bidder acknowledged by the auctioneer shall be the buyer. The auctioneer reserves the right to reject any bid and shall advance the bid at his/her sole discretion.
- 3) Some lots offered for sale may be subject to a reserve, which is a confidential minimum price below which a lot will not be sold. Consignors are prohibited from bidding on their own property; however, the auctioneer may implement reserves by bidding on behalf of the consignor.
- 4) Title of each lot passes upon the fall of the auctioneer's hammer to the highest acknowledged bidder. Thereafter, any loss by fire, theft, breakage, or any other cause is the sole responsibility of the purchaser. Merchandise must be packed and transported by the purchaser at his/her own risk and expense. Under no circumstances will Millea Bros.' liabilities to a purchaser exceed the purchase price actually paid.
- 5) The purchase price of each lot shall be the amount of the successful bid plus a twenty-four percent (24%) buyer's premium on the first \$500,000 and seventeen percent (17%) buyer's premium on the portion exceeding \$500,000. **BUYERS WHO PAY THEIR INVOICES IN FULL WITHIN 14 DAYS OF THE OF THE AUCTION DATE WILL PAY A REDUCED BUYER'S PREMIUM OF 20%.** Unless exempt by law, all purchases, including buyer's premium, are subject to all state and local taxes applicable at the time of payment.
